WARRANT AND CERTIFICATE PROGRAMME

This Fifth Prospectus Supplement (the **Prospectus Supplement**) to the Prospectus dated 2 August 2011, as previously supplemented by the first supplement dated 14 October 2011, the second supplement dated 9 February 2012, the third supplement dated 17 February 2012 and the fourth supplement dated 18 May 2012 (together, the **Prospectus**) which together comprise a base prospectus constitutes a prospectus supplement for the purposes of article 13 of Chapter 1 of Part II of the Luxembourg Act dated 10 July 2005 on prospectuses for securities (the **Prospectus Act**) and is prepared in connection with the Warrant and Certificates Programme (the **Programme**) established by Banca IMI S.p.A. (the **Issuer**). Terms defined in the Prospectus have the same meaning when used in this Prospectus Supplement.

This Prospectus Supplement is supplemental to, and should be read in conjunction with, the Prospectus issued by the Issuer.

The Issuer accepts responsibility for the information contained in this Prospectus Supplement. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case) the information contained in this Prospectus Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.
